5. Conclusion

Your conclusion should remind your readers of your argument and supporting evidence. You should emphasize on your take about abortion in your conclusion. Your conclusion should restate the overall claim of your essay and the supporting evidence.

Your conclusion should:

- Restate your introduction. However, it should not talk about the same exact thing as your introduction since this will prove that you have not done enough critical thinking.
- Restate your thesis statement.
- Tell the readers why they should care about your abortion essay.
- Create a sense of movement to a more complex understanding of your essay's subject.
- Serve as your essay's climax.
- Have concrete language to avoid leaving the readers with the impression that your argument was vague and unsure.
